- 3. <u>Bob Reeves, Kerr Country Tax Assessor-Collector, presentation about setting of the tax rate for ESD3:</u>

Mr. Reeves reviewed the process for proposing and adopting the tax rate for ESD3 for 2024. At the August 28, 2023 meeting he will present the assessed values for the Commissioners to consider when proposing the tax rate.

4. Review and approve Meeting Minutes from June 26, 2023:

Jeff Mitchell moved to accept the minutes as presented. Amy Palmer seconded. The motion passed unanimously.

5. Fire Chief's Report:

Chief Holt reported 59 calls year to date; 10 calls to date for July — 7 brush fires, 1 grass fire, 1 vehicle fire, 1 assist EMS. He reported that their fundraiser BBQ/dance/silent auction made approximately \$35,000 which was down from last year. For next year they plan to revise the dance with the thought of appealing to a broader audience. They are currently looking at plans to expand Sub-Station 2 to accommodate additional vehicles and they will seek grants to fund that project.

6. Treasurer's Report:

Amy Palmer reported that balance as of July 24, 2023 was \$395,257.30. A deposit of \$16,093.25 was received on July 7, 2023. The Reserve account and the Emergency account have been opened at Peoples State Bank and funds will be moved into those accounts as approved by Commissioners at a previous meeting. Charles Carson will review the documents for the Promissory Note for the tanker later in the meeting. The full Treasurer's Report is attached.

7. Consider, discuss and take appropriate action on Treasurer's Report:

Ed Story moved to accept the Treasurer's Report as presented. Jeff Mitchell seconded. The motion passed unanimously.

8. Consider discuss and take appropriate action on Peoples State Bank accounts:

Charles Carson, Peoples State Bank, reviewed the Promissory Note for the financing for the 2023 Freightliner Truck (FIREVAC) Vacuum Tender Water/Fire Truck. The first payment of \$61,784.99 on a 10-year note will be due February 1, 2024. The documents were as expected from what the Board had approved in June and President Danny Langbein signed them.
